What personal data do we collect and why?

We will process any Personal Data you provide to us for the following purposes:

- A. To provide you with the services you have requested;
- B. To contact you if required in connection with your use of the website or to respond to any communications you might send to us;
- c. To inform you of any updates or offers we might periodically have available.

MOPOSA collects the following personal data:

- Personal identification information, this includes name, email address, phone number, address).
- Geolocation.
- IP address.
- Browser & device details we collect personal data about how you use our Website and the types of devices which you use to access our Website, such as computer, mobile phones or tablets.
- Any other personal data which you record on our Website.

How do we collect your personal data?

You directly provide MOPOSA with the personal data we collect. We collect personal data and process personal data when you:

- Register for a MOPOSA account directly on our Website or via one of our client venues.
- Voluntarily complete a customer survey, provide feedback/reviews on any part
 of our Website or message boards or via email, enter competitions, or make
 contact with us in anyway or ask to be included on our mailing list.
- Use or view our website via your browser's cookies.

MOPOSA may also receive your personal data indirectly from the following sources:

 Our client venues may use our widget on their website. Web widgets or website widgets are third-party applications that are embedded onto a webpage. They are independent page elements that can be of different forms, including clocks, calendars, chat buttons, feedback or contact forms, etc. We will collect your personal data if you use our widget on our client venue's website.

Who will we share your personal data with?

• We may share your personal data with other companies we use who support our business. These companies provide services such as IT and legal services.

- We have contracts with our service providers which address the safeguarding and proper use of your personal data.
- We may share your personal data in accordance with applicable law and, as required, with Government entities, the Courts or as part of litigation. We also may share your personal data when there are threats to the physical safety of any person, violations of this Privacy Policy or the Website Terms of Service, or to protect the legal rights of third parties, including our employees, customers, or the public.
- We may share your personal data with a third party, as part of a due diligence process in contemplation of a merger or sale of our business or in the event of liquidation, receivership or transfer of all or substantially all of the assets of our company provided that the third party agrees to adhere to the terms of the Privacy Policy and provided that the third party only uses your personal data for the purposes that you provided it to us. You will be notified in the event of any such transfer and you will be afforded an opportunity to opt-out.

How will we use your personal data?

In general, we collect, use, store, and process your personal data to provide services to you, to fix and improve those services, to develop new services, and to market our Suppliers and their products and Services.

MOPOSA collects your personal data so that we can:

- Facilitate you to manage all aspects of your wedding at your chosen venue.
- Resolve technical issues, prevent, investigate and resolve issues such as fraud or unauthorised access or breaches of the Website Terms of Service.
- Website analytics. Like most websites, we gather statistical and other analytical information collected on an aggregate basis of all visitors to our website to get a better understanding of where our users come from and to help us better design and organise our website. This non-personal data comprises information that cannot be used to identify or contact you, such as demographic information regarding, for example, user IP addresses where they have been clipped or anonymised, browser types and other anonymous statistical data involving the use of our website.

How do we store your personal data & lawful basis?

MOPOSA securely stores your personal data electronically. MOPOSA takes the security of your personal data seriously and ensures that both hard data and

electronic data is securely stored. Electronic data is accessed via secure connections and is stored in a high-security data centre with multiple backup and security systems. Multi-factor authentication protocols are used for server access.

What are your data protection rights?

The right to object to processing – You have the right to object to MOPOSA's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that MOPOSA transfer your personal data to another organisation, or directly to you, under certain conditions.
